CLASS ELIGIBILITY CRITERIA

- Be a U.S. citizen or legal resident alien
- Have lived in and currently work in Travis County for at least 12 months
- Be at least a high school graduate
- Be a registered voter, if a U.S. Citizen
- Must be a member of the Lake Travis Chamber of Commerce (Persons related by marriage cannot apply for same class year)

Selection Criteria:

Applicants must 1) show a sincere commitment to improving the community, 2) show evidence of motivation and interest in the community and 3) have the desire to increase their service to our community in key leadership positions.

Acceptance into the program is based on a subjective assessment of the information each applicant provides in this application. Because there are typically more applicants than class slots, applicants who are not accepted are encouraged to reapply. The Leadership Selection Committee will be the steering committee. The program is limited to approximately 30 participants annually.
